Dear Sir,

With reference to your offer at Sl.no. 3 above, we are pleased to award the subject work in your favour for a value of Rs. 64,23,401.51 (Rupees Sixty Four Lakhs, Twenty Three Thousand, Four hundred One and paise Fifty One only) with following stipulations :-

(1) The Agreement in the enclosed format (**Annexure-1**) on a non-judicial stamp paper of Rs. 100/- shall be entered between M/s MAHARASHTRA ENVIRO POWER LIMITED, Nagpur and Area General Manager (AGM) of the respective Area as per the terms and conditions contained therein and quantities to be disposed Area-wise (**Annexure-2**).

(2) The MEPL shall contact the Area Nodal Officer (Env.) of the concerned Areas for execution of agreement and finalization of programme of work including finalization of distance between each HEMM Work Shop/Store and CHWTSDf at Butibori.

- (3) Before commencement of the work, the distance between the HEMM Work Shop/Store and CHWTSDF at Butibori shall be physically verified jointly by MEPL, Area Nodal Officer (Env.) and the Nodal Officer (Env.) of respective project and the same shall be recorded and jointly signed as basic record for transportation charges.
- (4) The date of Commencement of Work shall be reckoned from 10th day of issue of this Work Order.
- (5) The payments shall be made in respect of providing the services by MEPL as per rates duly endorsed by MPCB as under :

Disposal charges for Incineration	Rs. 23575.20 per MT*
Transportation Charges (taking in to account 90% of the carrying capacity of the truck i.e. 8.10 Te per trip).	Rs. 5.03 per MT per KM*
Unloading Charges	Rs. 114.00 per MT*
MIDC Charges (on disposal, unloading & transportation charges)	5% on billed Amount
*All inclusive of Service Tax @ 14%	

- (6) Loading of Hazardous Waste (Used oil filters, hose pipes & cotton waste) into the trucks arranged by M/s MEPL, shall be the responsibility of Concerned Area/Sub Area/Unit. The actual quantities loaded by WCL shall be suitably recorded jointly by MEPL and the Engineer in charge /Project Nodal Officer (Env) and duly accepted by the Area Nodal Officer (Env.).
- (7) The payment shall be made at Area level by the respective Area of WCL and the paying authority shall be Area General Manager.
- (8) You are required to obtain license as per the provisions of Contract Labour (Regulations & Abolition) Act 1970, and submit the same to the respective Area General Manager, failing which, no bill will be paid against the work done.
- (9) The Work shall be executed and maintained as per the provisions of agreement and instructions of Engineer in Charge/Nodal Officer (Env) of the Project.
- (10) The Area Nodal Officer (Environment) of the concerned Area shall be responsible for overall co-ordination and implementation as per schedule and will be assisted by the Nodal Officer (Environment) of the respective Project/Unit.
- (11) This Work Order in duplicate is being forwarded to you for returning the second copy to the undersigned after affixing your signature in token of acceptance of Work award.
- (12) All statutory deductions (Income tax etc.) shall be made as per the rules and directions of Government.
